## RE: SEIU OPEN ENROLLMENT FOR ANNUAL LEAVE AND VACATION/SICK LEAVE

Pursuant to SEIU Bargaining Unit agreements, employees in Bargaining Units 1, 3, 4, 11, 14, 15, 17, 20 or 21 may make an Annual Leave/Vacation enrollment change during the annual open enrollment period in April. Departmental personnel offices must receive all enrollments between April 1, 2023, and April 30, 2023. The effective date of the election is the first day of the June pay period.

Personnel offices must process enrollment changes no sooner than June 13<sup>th</sup>, once the CLAS Monthly Accrual Cycle has posted the May accruals and departments have keyed all leave hours used for May.
