RE: PAYMENT HISTORY REQUESTS

The State Controller's Office (SCO) is accepting Payment History Requests electronically. The SCO has released a new Employee Payment History Request form (<u>PSD003</u>). Human Resource (HR) offices must submit completed forms via encrypted email to <u>reportingoperations@sco.ca.gov</u>.

SCO's primary method of communication for payment history requests is by email. If an agency receives a response from SCO asking for additional information, the agency must submit any items to SCO within the requested timeframe. If the SCO does not receive the additional information within the requested timeframe, the SCO will consider the request closed. If the agency still needs the payment history data after SCO has closed the request, then the agency will need to submit a new Payment History Request form.

The current processing time for payment history requests is two to three weeks upon receipt of a completed Employee Payment History Request form, PSD003. All applicable fields within the form PSD0003 need to be completed, but double check the following prior to submission:

- Section 1: The full SSN is entered
- Section 3: The "Employer Certification", "Standard", or "Detailed" box is checked
- Section 4: All appropriate signatures are provided, including the employee's authorizing signature when requesting payment data where the pay was issued by another department or facility.
