RE: 1959 SURVIVOR BENEFIT PROGRAM, 5TH LEVEL DEDUCTION

This letter announces an increase in the 1959 Survivor Benefit Program, 5th Level employee deduction amount from \$5.60 per month to \$6.35 per month effective with the July 2023 pay period. The amount was approved by the CalPERS Board of Administration for fiscal year 2023/2024 and authorized by the California Department of Human Resources and the California State University Chancellor's Office.

The deduction codes 077 and 078 identify Survivors Benefit in the payroll system. The deduction code 077 amount is \$2.00 and the deduction code 078 amount is \$4.35. The Civil Service employees impacted by the rate change include all eligible rank and file employees as well as those excluded from collective bargaining. California State University employees impacted are those excluded from collective bargaining. No action from agencies or campuses is necessary to implement this change. The Personnel and Payroll Services Division implemented the rate change to deduction code 078, by increasing it from \$3.60 to \$4.35, effective July 1, 2023.
