RE: 2024 SOCIAL SECURITY AND MEDICARE RATES

The Social Security Administration published the new 2024 Social Security (OASDI) and Medicare rates. For 2024, the withholding rate for Social Security remains at 6.20% on earnings up to the applicable taxable maximum amount. The annual taxable wage limit increased to \$168,600.00 per employee with a maximum contribution of \$10,453.20.

The Medicare portion remains at 1.45% on all earnings. As of January 2013, individuals with earned income of more than \$200,000 pay an additional 0.9% in Medicare taxes. These changes will take effect beginning with payments issued on January 1, 2024.
