## RE: FINAL UPDATE FOR TEMPORARY CANCELLATION OF DEFAULT STUDENT LOAN GARNISHMENTS

This letter is to provide a final update that supersedes <u>Payroll Letter #23-012</u>. The State Controller's Office (SCO) temporarily canceled default student loan garnishments per section <u>4513(a) of the COVID-19 Pandemic Education Relief Act of 2020</u> in the April 2020 pay period indicated in <u>Payroll Letter #20-004</u>.

Per the U.S. Secretary of Education's Default Resolution Group, the suspension for student loan garnishment remains in effect due to the Fresh Start Program for loans in default. Agencies and Campuses must not reestablish the 339 deduction code and 008 organizational code Student Loan Garnishment until a new withholding order is received from the requesting loan servicing provider.

To cancel a Student Loan Garnishment that was established per Payroll Letter #23-012, agencies and campuses must upload a STD. 639 via ConnectHR and select the Garnishments – STD. 639 Salary Garnishment option from the dropdown menu. If a garnishment was already withheld from the employee's pay warrant, the loan servicing provider will reimburse the funds directly to the employee and will not apply it to their loan balance. Employees should contact their loan servicing provider if they have any questions or concerns about their reimbursement.

SCO will no longer monitor the status of reestablishing the student loan garnishments that were canceled per section 4513(a) of the COVID-19 Pandemic Education Relief Act of 2020.
