RE: NEW RETIREMENT ACCOUNT CODES FOR RANK AND FILE EMPLOYEES IN BARGAINING UNITS 6, 9, 10, AND 13

The Department of Personnel Administration (DPA) announced in Personnel Management Liaison Memos 2011-018, 2011-019, 2011-020, 2011-030, and in an e-mail sent to departments on June 16, 2011 that the new labor contracts with bargaining units 6, 9, 10, and 13 included a retirement contribution rate increase effective May 16, 2011.

Due to the mid-month effective date, the retirement contribution increases were implemented as follows:

#### JUNE 2011

- Effective June 1, 2011, rank and file employees in bargaining units 6, 9, and 10 had their retirement contributions increased by an additional 1.5% for the mid-May effective date plus the 3% increase negotiated in the new labor contracts for June, totaling a 4.5% increase.
- Effective June 1, 2011, rank and file employees in bargaining unit 13 had their retirement contributions increased by an additional 2.5% for the mid-May effective date plus the 5% increase negotiated in the new labor contract for June, totaling a 7.5% increase.

The June 2011 retirement rate changes were implemented via an automated Employment History (EH) mass update of 505 transactions effective June 1, 2011. This mass update occurred on June 14, 2011. Turnaround Personnel Action Requests (PARs) (TAD) were issued from the mass update process and released on a flow basis.

### **Temporary Separations**

Employees on a temporary separation and off pay status the entire May 2011 pay period were not subject to the May mid-month retirement contribution rate increase in June 2011. The retirement account codes for these employees were changed to the July 2011 account codes and rates listed in the charts below.

Employees who returned from a temporary separation during the May 2011 pay period and who were on pay status any part of the May pay period were subject to the May mid-month retirement contribution rate increase in June 2011. The retirement account codes for these employees were changed to the June 2011 account codes and rates listed in the charts below.

#### JULY 2011

- Effective July 1, 2011, rank and file employees in bargaining units 6, 9, and 10 had their retirement contributions reduced to reflect the normal retirement contribution rate plus the 3% increase negotiated in the new labor contracts.
- Effective July 1, 2011, rank and file employees in bargaining unit 13 had their retirement contributions reduced to reflect the normal retirement contribution rate plus the 5% increase negotiated in the new labor contract.

The July 2011 retirement rate changes were implemented via an automated Employment History (EH) mass update of 505 transactions effective July 1, 2011. This mass update occurred on July 7, 2011. Turnaround PARs (TAD) were issued from the mass update process and released on a flow basis.

#### RETIREMENT RATE CHANGES\

The following charts reflect the new account codes and contribution rates from the employment history mass updates. Refer to SCO Personnel Letter #11-003 and CalPERS Circular Letter 200-081-10 for additional information on how to determine the correct account code to use.

The online IDLS and paycheck calculators have been updated to reflect the new retirement contribution rates. Revisions to the Payroll Procedures Manual and the Personnel Action Manual will be forthcoming.
