## RE: SHIFT DIFFERENTIAL KEYING PROCESS FOR BARGAINING UNITS 13, 18 AND 19

Effective January 1, 2023, the State Controller's Office (SCO) implemented a change to the payroll system for Bargaining Unit (BU)13 and BU19 to not withhold retirement contributions for shift differential payments that are locked-in to Employment History (EH) and included in the salary total for payment type 0 and for shift differential payments issued as supplemental payment type 2.

Departments can lock in the shift earnings ID for BU13 and BU19 by keying a 345 transaction beginning with the January 2023 pay period for eligible employees. SCO's quarterly retirement contribution refund process will be modified to end the refund process beginning with the January 2023 pay period.

Furthermore, shift differential payments for BU18 are subject to CalPERS deductions effective October 1, 2022, per CalHR's <a href="Pay Letter 22-37">Pay Letter 22-37</a> and updated <a href="Pay Differential 85">Pay Differential 85</a>. Departments can key a 345 transaction for eligible employees to lock-in the shift earnings ID in EH. SCO's quarterly retirement contribution refund process has been modified to end the refund process beginning with the October 2022 pay period.

Shift differential payments can still be keyed via the Payroll Input Process (PIP) if the shift earnings ID is not locked-in EH and will issue as a supplemental payment type 2.
