**LUMP SUM ISSUED FOR JULY 2022**

These employees may be entitled to the general salary increase (GEN) and/or special salary adjustment (SAL).

The report is on the ViewDirect or Mobius on-line report system under report ID PDB7883, report date March 21, 2023, and report name, "EMPLOYEES WITH LUMP SUM ISSUED FOR 07/2022" (listing available for 90 days). Entries on the report are sorted by agency, then by unit, and then by social security number. Agencies with no affected employees will have no data listed under the report ID. This is a one-time report and a hard copy will not be provided to departments.

Only personnel staff authorized to access ViewDirect and Mobius will be able to view and print this listing. For more information on accessing and printing ViewDirect and Mobius reports, please see the <u>ViewDirect and Mobius View webpage</u> on the SCO website.

Agencies must review listing PDB7883 to ensure that the records reflect the GEN and/or SAL, if entitled. Employees who separated from state service without fault prior to the effective date of the salary increase with lump sum pay extending beyond July 1, 2022 and who were eligible for the GEN and/or SAL at the time of separation should have their lump sum adjusted to reflect the increase.
