Agencies with no affected employees will have no data listed under the report ID. This is a one-time report, and a hard copy will not be provided to departments.

Agencies must review listing PDSQ0124 to ensure that the records reflect the SAL, if entitled. Employees who separated from state service without fault prior to the effective date of the salary increase with lump sum pay extending beyond July 1, 2023, and who were eligible for the SAL at the time of separation should have their lump sum adjusted to reflect the increase.
