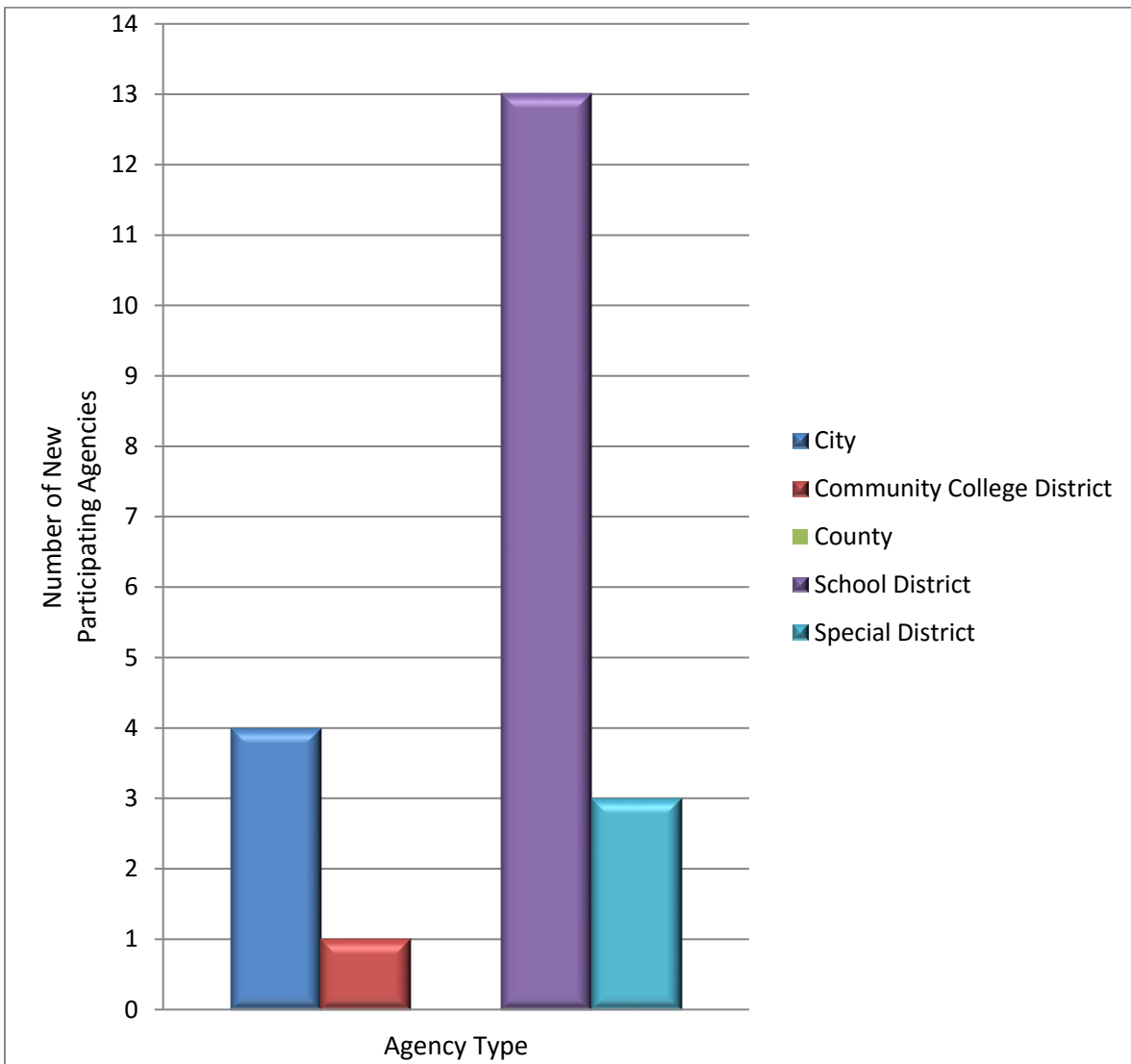

New Participating Agencies



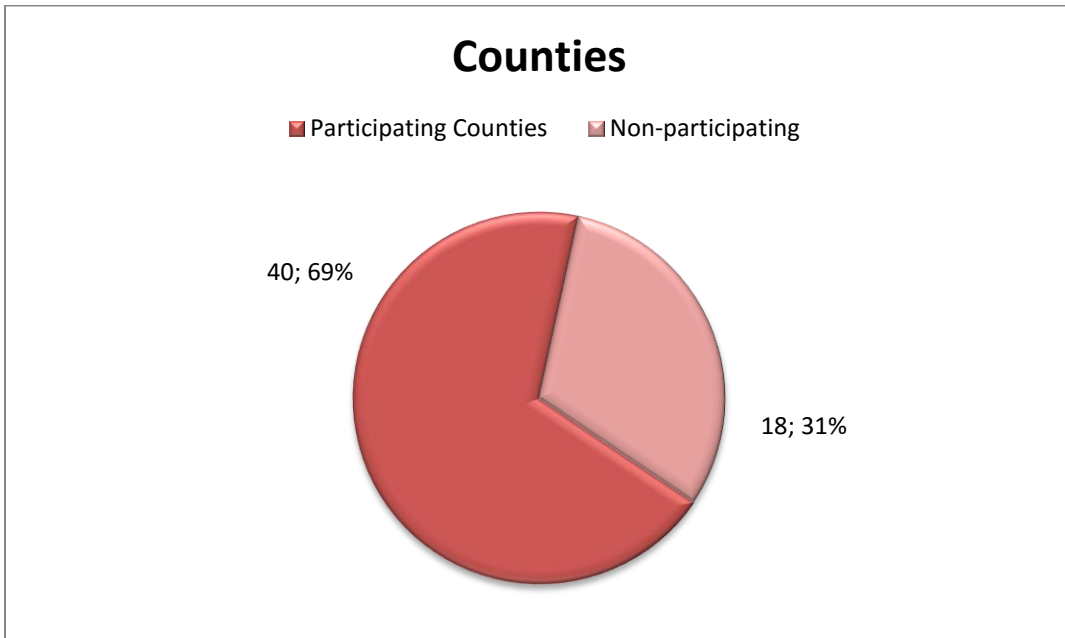
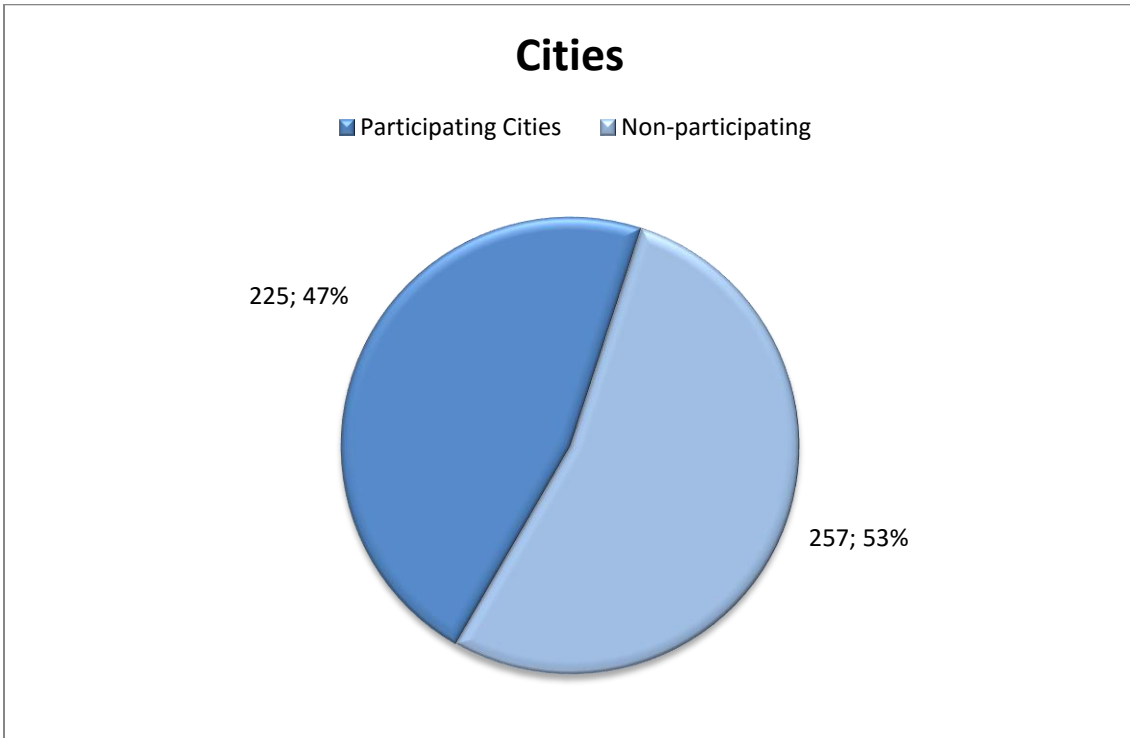
