RE: STATE MANDATED COST PROGRAM REPORT
CHAPTER 1124, STATUTES OF 2002, GC SECTION 15562(B)

Dear Senator Chesbro:

I have enclosed the report required pursuant to Government Code (GC) section 17562(b). This report summarizes data by state mandate and fiscal year, the total amount of claims paid, and appropriation deficiencies or surpluses for each program. The report includes program costs and payments for mandated claims filed with the State Controller's Office (SCO) for the fiscal years 1995-96 through 2003-04.

This report compares the annual appropriation to the statewide cost estimate adopted by the Commission on State Mandates. Statewide cost estimates are not available for all programs since the statewide cost estimate process was not established under the Board of Control.

The 2002-03 Budget Act, Chapter 379/02, section 11.80, directed that all unexpended general fund appropriation balances related to reimbursable state-mandated local agency programs be reverted to the General Fund. This action resulted in approximately \$40 million in additional deficiencies for local agency mandated cost programs.

The 2003-04 Budget Act, Chapter 157/03, Item 6110-295-0001, Provision 5, disallowed the SCO to make any payment from the 6110 item to reimburse community colleges for claimed costs of state mandated education programs. Any future reimbursements to community colleges are to be paid from an item in the community colleges budget. Therefore, the SCO has identified and reported appropriations and deficiencies for community colleges in a separate section of the enclosed report to comply with this provision.

Additionally, pursuant to GC section 17561.5, payment of accrued interest is required when payment is made more than 60 days after the filing deadline. As of June 30, 2004, the accrued interest due to local agencies and school districts was estimated to be \$93.2 million. The accrued interest will continue to accrue until the claims are fully paid. The accrued interest due to local agencies and school districts is not included on the enclosed report.

As of November 30, 2004, pending litigation on the mandates listed below may have a significant impact when the courts render their decisions.

- Pupil Expulsions;
- Property Tax Administration;
- Physical Performance Tests;
- Eastview Optional Attendance Area;
- Animal Adoption;
- Behavioral Interventions Plans; and
- Graduation Requirements Programs.
