Dear Controller Yee:

The Department of Finance respectfully submits the attached revised schedule for the August 2020 allocation of fiscal year 2019-20 funds deposited in the Youthful Offender Block Grant (YOBG) Special Account within the Juvenile Justice Subaccount in the Law Enforcement Services Account within the Local Revenue Fund 2011. This change is necessary so each county receives a minimum block grant allocation of \$117,000 for fiscal year 2019-20, pursuant to Welfare and Institutions Code 1955, subdivision (b). The county minimum payments on Attachment I are to be processed first, followed by the percent allocations on Attachment II.

The YOBG provides funding to counties for the care and custody of certain juvenile offenders who are no longer housed in state facilities, and instead are the responsibility of local jurisdictions.
