## RE: COVID-19 SUPPLEMENTAL PAID SICK LEAVE EXTENSION

On September 30, 2022, Assembly Bill (AB) 152 was signed which extended the COVID-19 Supplemental Paid Sick Leave benefit, which has a new termination date of December 31, 2022. The benefit will continue to use the same Leave Accounting code as outlined in Leave Letter 22-002, and acceptable usage of this benefit is outlined in California Department of Human Resource's policy <u>HR</u> <u>Manual, Section 2127</u>.

In summary, the features of the SPSL transaction code, first issued for Senate Bill 114 and extended with AB 152, related to COVID-19 Supplemental Paid Sick Leave are:
