RE: PAYROLL ONLINE INFORMATION SYSTEM CHANGES

The California Government Code requires that employers report employees' monthly rate of pay to California Public Employees' Retirement System (CalPERS) which can no longer include special compensation. Due to locked-in Earnings Identifiers (EID) and Shift Differential Codes (SD) the State Controller's Office, Personnel/Payroll Services Division (PPSD) found it necessary to modify the Payroll System. Effective August 1, 2018, Agencies will see changes to the Payroll Online Information System (HIST).

The payment detail in HIST displays the SD and up to three EIDs for payments when they are locked into Employment History. Effective August 1st, the payment detail screen will be modified to include the Base Pay amount derived from Employment History as well as the SD and EID gross amounts included in the payment if subject to retirement. The gross amount for EIDs not subject to retirement will be zero. Refer to [CalHR's website](#) for pay differential information.

The deduction detail screen will also be modified to display the SD and EIDs with the gross amount when an arrears adjustment for deduction organization code 003 is processed and impacts the SD and/or EIDs. The data contained in these fields are informational only used for reporting of special compensation amounts to CalPERS.
