This Payroll letter is to provide Agencies and Campus staff instruction to distribute the following information to all Civil Services and California State University employees.

Pursuant to California Government Code Section 1153(e) Bona Fide Associations must annually register with the appropriate authority. This letter announces the cancellation of unregistered Bona Fide Association payroll deductions not authorized by the Department of California Human Resources and the Chancellor's Office for fiscal year 2019/2020. The State Controller's Office will no longer withhold the deduction codes listed below from employee paychecks starting with the May 2020 pay period. No actions from agencies or campuses are necessary to implement these cancellations. Revisions to the Payroll Procedure Manual are forthcoming.
