The SCO created these reports to assist you in meeting requirements of the ACA. You will only receive reports if you have employees who meet the exception criteria identified in the report name. You will use these reports to enter missing ACAS data as indicated on the report. For accurate keying assistance, refer to the [ACAS User guide](#).

The first set of reports will include missing data from 1/1/15 through 4/30/15. Subsequent monthly reports will be available after close of business month. The reports do not include employees on a leave of absence or temporary separations. Continue to update those employee records as their employment status changes.
