RE: REVISED: EMPLOYEE NOTICE OF EXEMPTION FROM INCOME TAX WITHHOLDING

The 2020 employee notice of exemption from income tax withholding was mailed to the department/campus on December 31, 2020. Please distribute the notice of exemption from income tax withholding to employees indicated on the notice. Per Internal Revenue Services, Publication 15, their exemption from tax withholding will expire on February 15, 2021, unless it is renewed.

Civil Service (CS) and California State University (CSU) employees wishing to renew their exemption from tax withholding must file a <u>new</u> Employee Action Request (EAR) (<u>STD. Form 686</u>) or CSU Student Payroll Action Request (SPAR/<u>STD. Form 457</u>). New EARs/SPARs must be keyed <u>no earlier</u> than January 1, 2021, and <u>no later</u> than <u>February 18, 2021</u>. Effective with the February 2021 pay period, employees who do not file a new EAR/SPAR will have taxes withheld from their pay. The EAR withholding will be based on Single with no adjustments to Federal withholding (Section E. I (05-07)), nor any additional withholding (Section G. I (05-07)), nor any additional withholding (Section G. III (11)).

NOTE: Individual notices were mailed showing "New EARs/SPARs must be keyed <u>no earlier</u> than January 1, 2021, and no later than February 20, 2021" should reflect the February 18, 2021 due date.
