

## **RE:** AFFORDABLE CARE ACT SYSTEM – REMOVAL OF DASHES FROM SSN FIELD

In order to be consistent with the State Controller's Office (SCO) other Legacy mainframe systems, effective June 1, 2021, the Affordable Care Act System (ACAS) will no longer display dashes in the SSN field on the Main Menu screen. Please see the examples provided in the screenshots below:
