RE: RETIREMENT CONTRIBUTION RATE FOR EXCLUDED AND EXEMPT (M18, S18) STATE SAFETY MEMBERS IN BARGAINING UNIT 18; EFFECTIVE DECEMBER 1, 2022

Pursuant to the memo dated November 23, 2022, from the California Department of Human Resources (CalHR), the effective date for the retirement contribution rate increase changed from July 1, 2021 to December 1, 2022 for Excluded and Exempt (M18, S18) State Safety Members tied to Bargaining Unit 18.

Because of the change in effective date, eligible members will receive retroactive refunds for their over-funded retirement contributions.

The rate change is as follows:

Excluded and Exempt (M18, S18) State Safety Members in Bargaining Unit 18 Effective 12/1/2022, the employee retirement contribution rate will change from 11.00% to 11.50%.

Please note: <u>Personnel Letter #21-021</u> and <u>Payroll Letter #22-015</u> have been amended to reflect the retirement contribution rate changes for the remaining BU18 members.

EMPLOYMENT HISTORY (EH) PROCESSING

The State Controller's Office (SCO) will manually process corrections to appointments (A01) keyed prior to December 2022 and will void the 505 transactions effective July 1, 2021 to implement the retirement rate changes effective December 1, 2022 for eligible employees.

PAYROLL ADJUSTMENT PROCESING

The SCO will also process retroactive retirement contribution adjustments from December 2021 through December 2022 that resulted from the change in effective date for Excluded and Exempt Members tied to BU18.
