RE: MIRS Updates for Multiple Race/Ethnicity Origins

Assembly Bill (AB) 532 (2015/2016) and Government Code Section 8310.9, mandate that employees have the opportunity to designate multiple Race/Ethnic Origins. To accommodate this change, the State Controller's Office (SCO) created a unique area within the Affordable Care Act System (ACAS) for the key entry and storage of multiple Ethnic Code values.

Effective March 7, 2022, Human Resource offices began key entering Ethnic Code values in the new Ethnicity screen of the ACAS. As of the Friday, March 11 update to the Management Information Retrieval System (MIRS), the new Ethnic Code values are available in MIRS. MIRS report writers may now create reports with new and outdated ethnic codes. MIRS will be updated to include new and outdated ethnic code names soon.

The Personnel and Payroll Services Division MIRS Consultants are currently modifying the MIRS Common Library reports which contain ethnicity. A communication will be sent once the modifications are complete.
