# RE: MIRS UPDATES – ETHNIC NAME (NEW) AND ETHNIC NAME (OUTDATED) ADDED

As of the Monday, April 25, 2022, update to the Management Information Retrieval System (MIRS), the ethnic names that correspond to the two new ethnic code fields are available in MIRS. MIRS report writers may now create reports with new and outdated ethnic codes and names.

In addition to the new and outdated Ethnic Codes provided in the State Controller's Office (SCO) <u>Personnel Letter #22-006</u>, the MIRS Consultants have added values for Ethnic Code (New) and have added fields for Ethnic Name (New) and Ethnic Name (Outdated). Please see below for additional details:

## Ethnicity (New)

- Ethnic Code (New) (ETHNIC\_CD\_N) possible values:
  - Employee designated ethnicity code(s)
  - o Human Resources (HR) Office designated ethnicity code
  - o '' (Blank) indicates that the ethnicity is missing from the Affordable Care Act System (ACAS)
  - O Dash (-) use the Ethnic Code (Outdated) field to see the employee's ethnicity code
- Ethnic Name (New) (ETHNIC NAME N) possible values:
  - o Employee designated ethnicity name
  - o HR Office designated ethnicity name
  - o '' (Blank) indicates that the ethnicity is missing from ACAS
  - O Dashes (-----) use the Ethnic Name (Outdated) field to see the employee's ethnicity name
  - o MULTIPLE indicates that the employee has designated more than one ethnicity

# **Ethnicity (Outdated)**

- Ethnic Code (Outdated) (ETHNIC CD O) possible values:
  - o Outdated employee designated ethnicity code
  - o Outdated HR Office designated ethnicity code
  - o '' (Blank) use the Ethnic Code (New) field to see the employee's ethnicity code
- Ethnic Name (Outdated) (ETHNIC NAME O) possible values:
  - Outdated employee designated ethnicity name
  - Outdated HR Office designated ethnicity name
  - o '' (Blank) use the Ethnic Name (New) field to see the employee's ethnicity name
