ConnectHR: A Successful Launch to All State Human Resources Offices

The State Controller's Office (SCO) has successfully launched ConnectHR to all civil service (CS) and California State University (CSU) human resources (HR) offices. ConnectHR allows CSU campuses and CS HR staff to view information on behalf of employees who are not registered users of Cal Employee Connect. In addition, ConnectHR's file upload feature makes it convenient to submit secure personnel and payroll documents to SCO.

The file upload feature significantly reduces the time and cost required to send and process documents. Submitting through ConnectHR prevents document loss and provides users with receipts to track submissions. Access to ConnectHR is limited to users currently working in HR who have approved access to confidential State of California employee data.

ConnectHR exemplifies SCO's commitment to innovation and dedication to customer service. The platform was developed as an interim solution to provide some of the enhancements the California State Payroll System project will deliver when completed. SCO designed ConnectHR to support a hybrid remote workforce and automate payroll and personnel transactions, making them more efficient, sustainable, and paperless. We look forward to enhancing ConnectHR with additional features to serve the needs of our customers and welcome your input and feedback.
